personal staging of the individuals involved. Such criminal indictments are to be submitted to the State Police Branch Office in Würzburg, upon completion of the investigations, in three copies.

All possible care is to be put into efforts to recover the stolen goods, in particular items containing gold and precious stones. These objects are to be turned over to the Würzburg Branch Office of the State Police and are to be accompanied by an itemized list. This list will also include all objects now held in your custody, with a detailed description, and with an approximate indication of value either estimated by you, or based on the estimates of appropriate experts. Further, the former owners as well as the offenders (looters) are to be listed.
Deadline : 25 November 1938.

7) Other Jewish property.

In principle, use of Jewish property confiscated or taken into custody in the course of these events is prohibited. This includes in particular use of motor vehicles. Requests for permission to use such property, submitted by Government and Party agencies, or private individuals, will therefore serve no purpose.

8) Archives and Documents taken into custody.

The archives and documents taken into custody in the course of these events are to be collected under the supervision of your office and are to be held until further notice. Examination and pick-up will be arranged for by this office in due course. You

are requested to report on the location of the repositories.

9) Synagogues.

Reconstruction and repair of destroyed and damaged synagogues is prohibited until further notice.

10) Damages suffered by non-Jews.

Not later than 25 November 1938, a report is to be filed listing all damages suffered in the course of this action by non-Jews. The list must contain amount of damages, name of the non-Jew involved, name of the Jew against whom the protest action was intended to be directed. In determining the amount of damages, Jews of course are not to be questioned.

11) Possession of Weapons.

Your attention is directed to the order of the Reichs Minister for Internal Affairs of 11. November 1938 (German Law Journal I, Nr. 188, page 1573). If weapons and ammunition (82 of this order) have been found, they are to be confiscated and to be sent here. Criminal indictments are to be submitted here in three copies.
