Nurnberg, Germany
23 November 1945

1. ELECTRIC CURRENT IN NURNBERG: There will be no electricity on the city system on the following days: for Direct Current - Mondays, Wednesdays, Thursdays and Saturdays from 0700 to 1100; and for AC or Alternating Current - Tuesdays from 0800 to 1200, Wednesdays from 1200 to 1600, Fridays from 0800 to 1200, and on Saturdays from 1200 to 1600. The reason for this is low level water in the Munich area and the Bavarian Alps which supply most of the power to the Nurnberg area.
2. IMMUNIZATION: All OCC personnel who have not received an injection of influenza vaccine will do so before the end of next week, in Room 24. Please take care of this as soon as possible. You must bring your Immunization Card with you.
3. AMERICAN TRAVELER COPIES AVAILABLE: Please pick up your copy of the American Traveler in Room 115. There is a limited supply only.
4. SUNDAY TRIPS: There are no more accommodations for the Sunday trips.
5. CONCERT - NURNBERG OPERA HOUSE: The concert this Sunday will consist of Chamber Music - 1400 - no tickets required.
6. PRESS PASSES: Representatives of the press and radio have been assigned all the seats beyond the barrier on the ground floor and in addition 25 seats in the visitors' gallery. Press passes are issued by the *Executive Office but only upon request of Lt. Col. Madary, who is the representative of the Director of Public Relations, USNET. Personnel of the Office of U. S. Chief of Counsel are not permitted to occupy seats assigned to the press and radio. *Executive Office - Rm 122.
7. SEATS IN COURTROOM: Seats at the trial table assigned to the U. S. Prosecutor are allocated from day to day by Colonel Storey. Seats along the barrier have been made available to the U. S. Prosecutor during the presentation of the U. S. case. Allocations of these seats are made from day to day by Colonel Gill.
8. TRIBUNAL PASSES: Tribunal passes are issued by the Executive Office, Rm 122, to personnel who are expected to have official business requiring entry into the Tribunal room. Heads of all Divisions and Sections are requested to instruct personnel of their units that Tribunal passes are to be used only when the holder is on official business.
9. VISITORS' TICKETS: Persons desiring to visit the hearings for other than official business must secure visitors' tickets for seats in the visitors' gallery. Requests for visitors' tickets should be made of the Executive Office, Room 122, before 1730 hours of the preceding day and the tickets may be picked up by 0915 hours of the day on which they are to be used. It should be borne in mind that most of the tickets in the visitors' gallery are allocated to the participating and adhering nations of the agreement of 8 August 1945.

10. ILLNESS: Because of the increasing number of personnel sick in quarters, it is requested that all personnel requiring medical attention at home will please notify the Dispensary at the Court House by 1000 A.M. Otherwise, except in emergency cases, the Medical Department may not be able to make necessary arrangements for examinations, medicines, or transfer to the hospital when necessary.
